### Manufacturer's warranty

All Amorim Cork Flooring wall coverings are covered by a LIFETIME STRUCTURAL WARRANTY. We certify that each product is free from manufacturing and structural defects and will remain free of these defects for the entire life of the product.

#### WARRANTY TERMS AND CONDITIONS

The assertion of warranty claims against Amorim Cork Flooring is subject to compliance with the following terms and conditions:

- The warranty is valid from the date of purchase as shown on the customer's invoice.
- The warranty applies only to the original user and covers only approved product applications.
- The warranty applies to wall coverings used exclusively in interior areas, excluding wet or damp areas such as bathrooms or saunas.
- The warranty is only valid if proper installation, cleaning and maintenance procedures are followed.

#### **EXCLUSIONS**

The following are expressly excluded from the present warranty:

- Defects, which are not related to the manufacturing process.
- · Defects or damage caused by transportation.
- · Expanding and contracting of the cork wall tiles/panels.
- Defects or damage caused by installation that does not comply with the recommended installation
- procedures. Any failure, as a result of improper installation, is the sole responsibility of the contractor and/or installer.
- Deficient or inadequate support (wall).
- · Inadequate product choice for the use conditions.
- · Labor on material installed with obvious visual defects.
- Dissatisfaction in color, shade or texture variations from samples, batch, exposure to sunlight or replacement.
- Damage due to improper or not recommended care, maintenance or refurbishment.
- Unapproved modification or repair.
- Damage due to exposure to excessive heat, cold, moisture or dryness (more than 70% or less than 30% R.H.).
- · Problems due to moisture, mildew or chemical substances.

• Damage due to stains, scratches, gouges, scuffs, punctures, tears, fading, indentations, burns, improper storage, insect infestation or other incident such as fire, flood or abuse.

- Accidents, abuse, misuse or force majeure.

#### WARRANTY COVERAGE

This warranty is effective in addition to the statutory warranty and all other rights the buyer is provided with by law, including the rights of the buyer with regard to the seller.

If, unexpectedly, a defect is verified, Amorim Cork Flooring distributor will arrange for the repair or replacement of the defective product; if the wall covering needs to be replaced, the replacement material will be the same design and coloration as the original. If the original wall covering is no longer available, then other product of equal value will be supplied. Amorim Cork Flooring will repair or replace a wall coverings one time during the life of its warranty.

Amorim Cork Flooring excludes and will not pay consequential damages under this warranty. Repair or replacement of the material is the sole remedy.

This warranty includes the replacement of the defective wall tiles and/or the cost of labor, according to the table below.
